Gentlemen:

In accordance with the contract clause entitled "Ordering of Work" contained in the referenced contracts, it is intended to issue a contract task order to the successful offeror for the following project:

Project No. 09-0482, Renovate Heads, Bldg 223

A pre-proposal conference will **not** be conducted for this project. Your proposal, to include your cost estimate and a list of subcontractors to be utilized under each task order, shall be submitted to the attention of the undersigned at this office by not later than **1000, Friday, 24 July 2009**. Electronic submission of proposals may be emailed to minimacc@navy.mil. Receipt of your proposal is subject to FAR 52.215-1, Instruction to Offerors – Competitive Acquisition (JAN 2004) contained in Document 00201. Please note that no bid bond is required.

Your proposal will be reviewed and evaluated based on price and past performance. You will be contacted to discuss minor clarifications or questions concerning your proposal and to establish a specific time if negotiations are conducted. We intend to evaluate proposals and issue a task order without discussions (except communications conducted for the purpose of minor clarification). Therefore, each initial offer should contain the offeror's best terms from a price standpoint. However, the Government reserves the right to conduct discussions if later determined by the Contracting Officer to be necessary.

Quality Performance...Quality Results

The Contract Completion Date (CCD) is 120 Days after award.

The contractor will coordinate work schedule and access to work with the POC LtCol Melso (micheal.melso@usmc.mil) 2nd Marine Regiment 451-1838 or Maj. Catanzarito (john.catanzarito@usmc.mil) 2nd Marine Regiment 451-0152.

The contractor will start and complete Head #2 prior to starting work on Head #1. Head #2 will be fully operational and available for use by the occupants before starting Head #1.


The contractor will provide, maintain, and empty 2 each porta-potties while Head #2 is unavailable for tenant use. The portable heads will be removed within 48 hours of Head #2 becoming available for tenant use.

You may contact the OICC at (910) 451-2581 to inspect site conditions, review available as-built drawings, or inquire about other on-site technical details. Any changes to the scope of work will be effected on a Standard Form (SF) 30.

This request does not constitute notice to proceed nor shall it be considered as a commitment on the part of the Government. Any costs incurred prior to issuance of a task order cannot be reimbursed. Costs of such nature are considered to be for the benefit of the Contractor and are incurred at his discretion. The successful offeror will be issued a task order, which will take the form of Department of Defense (DD) Form 1155, under their contract as set forth in FAC 5252.216-9306, Procedures for Issuing Orders (MAR 2002). Direction to proceed for each task order issued will be provided upon receipt and approval of an acceptable performance bond and payment bond under each task order.
