Question: The plans indicate two columns at each side of the pavilion totaling four. With the overall dimension 20 ft x 20 ft we feel the span would be too great to support the trusses. Do we need to price installing 8 columns?

Answer: 2ea 11-7/8 LVL meet the load limit for the 20'-0 span requirement. There is no need for additional post.
